INSURANCE & BENEFITS REPORT – APRIL 2024

As I write this article, Spring is just a couple of weeks away, but the weather has been terrific.

Many of you know that there was an issue with the February pension amount. Bswift, the new company Caterpillar hired to run the insurance administration, accidentally sent out the second Medicare reimbursement payment five months early. All those that received this overpayment should have gotten a letter telling you that you can keep this overpayment. That they will just skip July's payment. Those that only got January's Medicare reimbursement will still get the regular July reimbursement. If you do not get that July's payment you will need to call Bswift at 1-833-735-2127.

A reminder to all of those that are on Long Term Disability (LTD) or receive a pension and don't have your premium come out of your monthly check to make sure you are paying your monthly bill that Bswift sends you. If you haven't received a bill for your premium, please call Bswift immediately. This does not concern those that are on Short Term Disability (STD) or have their premium come out of their pension check before you receive the monthly payment.

In closing, I want to say that in all my years being involved with the Benefits office I have gotten to know a lot of great people and have gained a lot of friends over those years. Many of these people I care deeply about and feel that they truly are my Brothers and Sisters. I know it is a part of life that we all die, but it hits hard when you love someone like a brother or a grandpa that passes away. The Union lost two unbelievable guys in January and February. John Shallenberger passed away on January 22nd and was a great friend, mentor, and a true Brother. On February 24th Bill Corum passed away. He was like an adoptive grandpa to me. Bill was one of the warmest and friendliest people you could ever meet. Love and prayers to their families. John, Bill, thank you for everything you have done for me in my career with Caterpillar/UAW and my personal life. I can never repay you for what you guys did. May you both Rest in Heaven!

RETIREES - Medicare Reimbursement

From time to time, I remind our retirees about the Medicare Part B reimbursement portion of our plan. If you or your spouse are Medicare age, 65, and enrolled in Medicare Part A & B, you are eligible for reimbursement of the Part B Premium. **The Plan will reimburse your Medicare premium up to \$99.50 per month every January and July.** This only pertains to members and spouses that opted out of the management/executive plan and retired prior to March 26, 2017. **You must contact Alight Solutions (Hewitt) at 1-877-228-4010 to enroll for the reimbursement. Once you're signed up, you won't have to sign-up again.**

COMING TOGETHER

Sunday, April 28th, 2024 at 3:00PM - Workers Memorial Monument Site, Peoria City Hall

Please join us for a brief memorial service to honor our fallen Brothers & Sisters who have died or have been seriously injured because of workplace accidents since we last met one year ago.

In 2017, federal agents raided three Caterpillar offices in Illinois seeking documents related to the company's taxes. The following year, Caterpillar revealed in an SEC filing that the IRS was seeking \$2.3 billion in taxes and penalties. Soon after William Barr, who had represented Caterpillar, was appointed U.S. Attorney General in 2018, the investigation "stalled," according to a Reuters report. (Caterpillar settles IRS tax dispute with no penalties | Equipment World) The IRS's interest in Caterpillar's taxes stemmed from a wrongful termination lawsuit filed by a former Cat accounting executive in 2009. Daniel Schlicksup accused the company of shifting U.S. profits offshore to shell companies in Switzerland and Bermuda. Schlicksup alleged he had alerted Caterpillar executives of illegal tax treatments in 2007 but was ignored and later retaliated against. The company insists that everything it did was aboveboard and that it investigated all of Schlicksup's complaints over the years about the Swiss setup. **Schlicksup maintains that supervisors hushed up his complaints and retaliated against him by eliminating his position and transferring him to the IT department. "The message to me was clear," once he testified. "We're going to hurt you a little, and if you don't keep quiet, we're going to hurt you a lot."** He left the company in 2012, and the case is pending. It's unclear whether the Justice Department will go after Caterpillar on criminal charges, but that wouldn't affect the IRS' attempt to recoup \$2 billion. The 55-year-old is a former accounting executive at the world's biggest maker of bulldozers, and as a long feature at **Bloomberg** explains, he just might become the highest-paid corporate whistleblower in history. As in, up to \$600 million if what he says is true and the IRS is able to collect. The IRS, which raided the company headquarters in Peoria, Ill., in 2017 thinks Caterpillar owes about \$2 billion. Under the agency's own formula, whistleblowers are entitled to up to 30% of whatever it collects. **(Former Caterpillar Accountant Daniel Schlicksup May Become the Best-Paid Corporate Whistleblower of All Time) (newser.com)**

"We're going to hurt you a little, and if you don't keep quiet, we're going to hurt you a lot." This statement from Mr. Schlicksup was very surreal to me because I have been in this situation and other UAW members have had the same experience. Recently, a UAW member was accused of hitting another employee's car in the parking lot, but because it was a UAW member who supposedly hit a manager's car the company got involved. If it had been two UAW members, they would have handed it over to East Peoria Police and forgot about it. The employee said he did not hit the vehicle and management indefinitely suspended the UAW member. **This is management's number 1 way of punishing the employees, by putting them out of work and hurting them financially to starve them into submission.** I believe Management chose the wrong UAW employee to make an example of because this UAW employee would not submit to management's so-called "values in inaction". This UAW employee, with the help of our local grievance committee, made a great case in arbitration because the truth was on the UAW member's side.

It takes courage to fight for the right reasons. A lot of our UAW members have less than 5 years of service and are not seasoned to this type of environment, but if we come together and do the right thing together in Solidarity, we can fight for the right reasons together. I have been at Caterpillar for over 20 years



now and I have been a steward or safety representative for 16 of those years. Unfortunately (for the last 10), I have seen a decrease in members that file safety complaints. I have members come to me all the time with legitimate concerns and have had no help taking it to their supervisor. I advise them to tell their supervisor that they want to request a UAW Safety Representative, and the response I get back is “I don’t want a target on my back”.

We must stand together when there is an issue, especially a health and safety issue, that needs to be addressed. Action against those who truly seek to make improvement for all cannot be tolerated. We have to choose our battles wisely but act decisively when necessary. Call your UAW Health and Safety Representative if problems you bring to management’s attention and are not corrected to your satisfaction. Our Safety Complaint Process is effective if we would just use it instead of the silly CI cards. If you choose not to say anything, not to address a problem, you’re just burying your head in the sand. I’ve got news for you, when your head is in the sand, there’s still a lot of you still exposed.

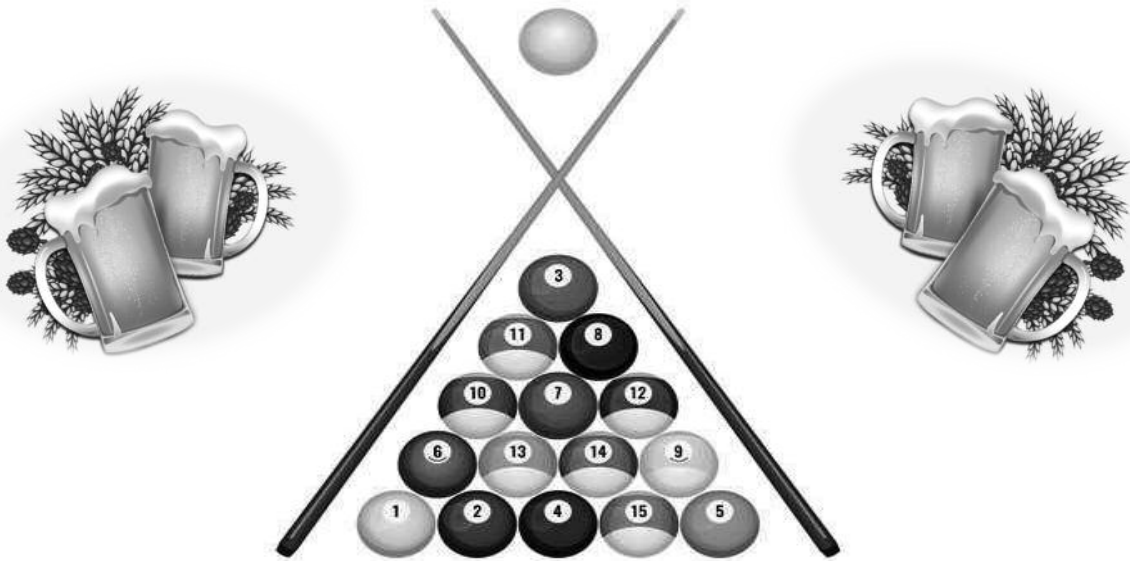

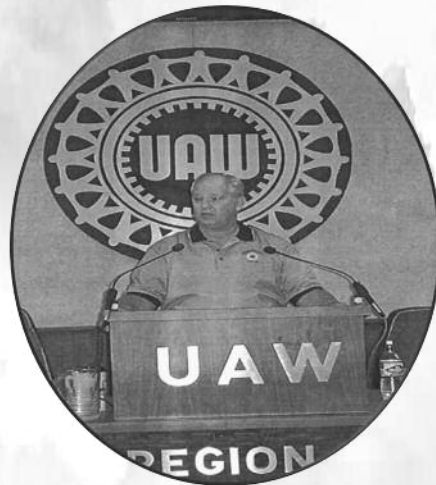

BARGAINING CHAIRMAN'S REPORT – APRIL 2024

BOBBY KOLLER _____

Greetings Brother and Sisters,

Docket numbers – Issue grievances are 3 and just cause grievances are 9.

There has been a steady flow of grievances coming from the committees since the first of the year. A lot of times these signals things slowing down. Some business units may be a little slower but reports coming from others are still going good.

We continue to have quarterly docket meetings with the company to resolve grievances and I believe that process is going well. The next docket meeting is for East Peoria on March 14, 2024, we have 6 grievances to argue there. Four (4) out of TBU, 1 in Prime Products and 1 in Undercarriage. We also have docketing coming up for Morton soon.

We received the arbitration ruling on Wednesday, March 6th for the TBU Business Unit. I have talked about this case recently in Steward meetings and talked about back pay. Generally, you won't hear me talk about back pay a lot because to get back pay you must find that the Company really didn't have any reason to discharge the person. The Company is careful not to show complete negligence when suspending someone, but we felt strongly in this case. The arbitrator awarded partial back pay.

On March 8th there was 3% form wages earned in 2023 put into the 401K.

On March 29th there will be a 4% payout for all active members employed as of December 31, 2023. I have been getting asked a lot of questions on what's included. This will be hours worked from January 1st to December 31st of 2023. Overtime hours are included at straight time hourly rate, times current base rate of pay, times 4%. This will be paid out on March 29th.

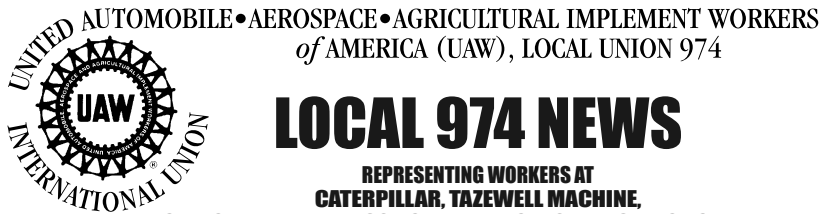
