

BARGAINING CHAIRMAN

RICK DeGROOT, Bargaining Chairman

Greetings Brothers & Sisters:

We currently have a total of 1,394 active grievances in the arbitration backlog.

As of 11/1/12 we have 32 discharges in our Local – East Peoria has 7 discharges; Mapleton has 2 discharges; Morton has 20 discharges; KK TBU has 3 discharges; and Mossville, Tech Center and SPBU have zero discharges.

ARBITRATION

12-MAP-002 Chris Grimm – Overtime grievance outside of 4.1. The grievance was sustained in part and denied in part. The company violated the provisions of section 4.1 when it allocated overtime to 2nd shift 3F42 employees under 4.1(d) before offering the overtime to the grievant under section 4.1 (c). However, the Union's claim for financial claim is denied.

Under Arbitrator Kenis we have arbitration dates. On 9/18/12 we heard Lester Chandler's Grievances, 99-HH-23, on his demotion from 2M11 and on 9/19/12 we heard John Pilkington's Grievance, 01-LL-31, on demotion from a 1W14 classification. We are waiting for the rulings to come back.

The following grievances were settled prior to arbitration: 89-HH-79, Jim Searle & 89-HH-87 John Higginbotham. On Jim Searle's grievance, all overtime grievances were settled for each employee to be paid 48 hours regular pay.

99-LL-54, 99-LL-63, 99-LL-64 and 01-LL-003, all Wes Hogsett's grievances on improper layoff for union representation was settled. The company recognizes that section 5.2 of the 1998 Local Supplement for the Peoria Area Facilities applies to Union Committeemen and Stewards during a temporary layoff.

On 9/26/12 we heard Jennifer Measheaw, 09-MOR-004 for holiday pay. We are waiting for the ruling to come back from this hearing.

Steven Hayford will be the new arbitrator for discharge cases. We are scheduled to arbitrate on November 13th in KK and December 7th Morton. January, 2013 we will be back on the regular schedule.

TEMPORARY LAYOFF

East Peoria Business Unit is planning a one-week shutdown in November and December. Mapleton Business Unit is planning a two-week shutdown in December. Mossville Business Unit is planning a one-week shutdown in December.

MORTON

In Morton we have a huge problem with disciplinary actions over claims on employees picking parts. The Company has just informed us they are putting the same policy in place for inbound employees. I sent Dave Howell a letter stating this change has affected the terms and conditions of employment for UAW-represented employees and has resulted in numerous instances of disciplinary actions being taken against our members. I believe the Company has violated Section 8(a) (5) of the National Labor Act. We are willing to meet with Caterpillar for the purpose of bargaining over the decision to implement the Quality Policy at the Morton Facility. We are also in the process of filing a Labor Board Charge over the Quality Policy in Morton.

We have a steward council meeting the 4th Thursday of each month, which by our bylaws stewards are required to attend, but everybody regardless if you are a steward or not are welcome to attend. The times are at 8:00 am, 12:00 noon and 4:00 pm on the 4th Thursday of each month. We will dedicate part of the meeting for steward training. Then each month we will cover different articles in the contract.

INSURANCE & BENEFITS REPORT

JIM ARROWOOD, Chairman Insurance and Benefits

I wish our deadline for this newsletter was November 7th. Although this article is being submitted four days prior to Election Day, I am confident that you did your part and voted for our Labor friendly candidates.

The annual enrollment period will also have come and gone by the time you read this. Hopefully you have gotten enough information to make an informed decision concerning enrollment. For 2013 health plans keep in mind how our premiums are set. All premiums are set by a formula that has been in place for a long time. The total annual participant cost per member is arrived at by the unadjusted percent change of the medical care component of the consumer price index for all urban consumers, U.S. City average.

With rolling layoffs for active members, we need to be sure we are staying current with our medical premiums while we are not on the bi-weekly payroll. Hewitt is the administrator for all enrollment and eligibility issues. Caterpillar is responsible for all rolling layoff decisions, therefore get it clear with management prior to any layoffs. The last thing you want is a disenrollment based on non-payment of premiums.

Remember, the December Membership Meeting is at 1:00 pm on the 9th. This is an important meeting. All members have an opportunity to attend and get year-end reports from all officers.

RETIREEES – Medicare Reimbursement

From time to time, I remind our retirees about the Medicare Part B reimbursement portion of our plan. If you or your spouse are medicare age, 65, and enrolled for Medicare Part A & B, you are also eligible for reimbursement of the Part B Premium. The **Plan will reimburse your premium up to \$99.50**. You must contact Hewitt at 1-877-228-4010 to enroll for the reimbursement, both the member and spouse are eligible.



He sent a Savior





MOSSVILLE GRIEVANCE COMMITTEE REPORT

PAUL JACKSON, Chairman

Dateline: November 1st, 2012. This is the date this article goes to the Editor. This gives you the reader a reference for the facts and statements contained in this article.

END OF THE YEAR.....NOT THE WORLD

I hope! The Mayans predict the world will end in 2012.....December 21st? I don't believe that, but if so, since this may be my last article, I better make it a good one.

END OF THE WORLD.....NOT THE YEAR

I hope not! On the other hand if you are reading this article, it is December and if Romney won, life as we the Middle Class know it will surely end.

MAPLEVILLE

It has been a rough year for the Mossville side of the Business Unit. Continued reductions in force, resourcing and now some scheduled TLO's in December.

The contract has been changed. In bargaining we replaced the contributory SUB-Fund with a non-contributory Supplemental Fund. Here's how it works. Benefits are paid out automatically. We no longer HAVE to be eligible for Unemployment and the money you receive is not counted against the Unemployment you are entitled too. Caution.....if you are laid off more than a month, you may receive an invoice of payment due on your health insurance premiums. If you receive such a notice, DO NOT DELAY, pay it immediately. Jim Arrowood, our benefits Chairman tells me an overpayment is not a problem, his office can rectify that error, failure to pay is next to impossible and really most likely impossible to fix.

As of now management are talking TLO week prior to Christmas shutdown and vacation shutdown during Christmas week. The Union hall is scheduled to be open both weeks, if you have specific questions or problems during that time.

Grievance backlog has been small and management has been addressing most problems prior to a grievance being filed or in the earliest steps, as per contract. Mossville has issue arbitration scheduled for November 7th and the case on the docket involves the application of the bid procedure language. The issue at hand is when do bid restrictions start. The Union believes, as per contract, bid restrictions start as soon as you are posted as successfully bidder (and in 86 when corporate gave training classes, that the way it was laid out to us). Now, they are taking the position it not only starts when you get the bid, but starts over again when you are moved to the job. So essentially if you have a 12 month bid restriction and it takes them 3 months to move you to the job it now becomes a 15 month restriction. We are asking the arbitrator to rule on the interpretation of that language. The Company wants it

BOTH ways, whereas the contract, we think the language is clear. A 12 month restriction does not allow the Company to exceed those restrictions set by contract.

We have a new "Just Cause" panel arbitrator, Steven Hayford and although he will hear a couple of cases prior to the end of the year, Mossville's next regularly scheduled, by contract, arbitration will be February 7th and 8th, 2013.

Rick DeGroot, servicing reps and myself have been working diligently on the International arbitration backlog, under Rick's plan we have been able to reduce that backlog from 4,000 plus to less than 1400. In addition under the new screening committee, instituted by Dennis Williams and Dave Curson, we have been successful in keeping the docket from getting "backloaded", while we are working on the front end.

Our Mossville represented Mapleton members on the BB/DD liner lines are as of now looking at a 1 week TLO during the week of December 17th and Christmas vacation shutdown. The 7m10 head line operators are , as of now, looking at the week of November 26 for a TLO and may be working Christmas shut down, or at least be offered.

On my way back from this year's Labor Day parade, I heard a retailer talking about a special visit from a Santa later on that month. 




