

We had approximately 180 members march in the Labor Day Parade in West Peoria, IL.


We awarded (11) \$500.00 scholarships at the September General Council meeting and expect to raise that number this year.

RETIREES - Medicare Reimbursement

From time to time, I remind our retirees about the Medicare Part B reimbursement portion of our plan. If you or your spouse are Medicare age, 65, and enrolled in Medicare Part A & B, you are eligible for reimbursement of the Part B Premium. **The Plan will reimburse your Medicare premium up to \$99.50 per month every January and July.** This only pertains to members and spouses that opted out of the management/executive plan and retired prior to March 26, 2017. **You must contact Alight Solutions (Hewitt) at 1-877-228-4010 to enroll for the reimbursement.** Once you're signed up, you won't have to sign-up again.

BARGAINING CHAIRMAN'S REPORT – FEBRUARY 2026

Greetings Brother and Sisters,

The current docket numbers are 3 issue grievances and 5 just cause grievances. I have 5 grievances pending certification. So, these docket numbers will go up.

As 2025 is now gone, I hope that 2026 will be a very good year for our membership. We are hearing about new products and new investments at our business units. The AG-Imp in other locals like John Deere and Case seem to have hit a downturn in their businesses. I hope the best for those Locals as well.

With the New Year there are some key dates I would like to share.

- 1) Vacation reset is January 12, 2026. (Overtime reset)
- 2) Vacation bank payout from previous year is by February 15, 2026.
- 3) 3% lump sum to be put into TDRP in the first quarter.
- 4) By March 31, 2026, a 4% lump sum of hours worked from January 1, 2025 through December 31, 2025, will be paid out.
- 5) April 6, 2026, reset of Y-time. (Punch in for 6 minutes)
- 6) June 15, 2026, payout of previous years Y-time.

We have covered all the Central language of the contract in the Steward meetings. We now are starting with the Local language.


