

Also, congratulations to all of the new officers installed at the General Council Meeting on June 8th. I'm looking forward to working with everyone

the next three years as we work towards representing the Membership – active & retired.

The newly elected Division Grievance Committees are in the process of posting and holding the shop floor Steward elections, so check the Union Boards in all of the buildings to keep informed of any elections if necessary. By the time this paper is mailed out, most of these elections should be decided. If your area did not have anyone run for Steward and you are interested contact the Grievance Committeeperson and tell them of your interest. We have had some areas where there were no Union Stewards and we like to fill these openings in an effort to represent, communicate & educate the Membership of their rights in their daily endeavors with management.

There is also an election of the Local 974 General Council Delegates to be held on September 7th. These Delegate positions up for election are part of the governing body that makes decisions on managing Local 974 affairs. The posting for this election is in this issue of the newspaper and on the Union boards in the shop. If you are interested in becoming a part of the Union leadership be sure to fill out a nomination form and turn it into the Hall during the posting period.

#### **ARBITRATION NEWS**

We did get back the arbitration awards mentioned in the last article of the newspaper. Arbitrator Kenis did return three decisions:

Grievance 12-LL-88, T. Bauer, on a last chance agreement. It was lost.

Grievance 05-LL-81, S. Swanson, on wages. It was lost.

Grievance 12-HH-09, D. Perry, on job bid. This was also lost.

Announced Vacation Shutdowns & TLO Shutdowns

Below is a list of the vacation shutdowns and TLO (temporary layoff) shutdowns...

East Peoria:

Bldg. KK – Week of July 14th for most employees. The TLO weeks will be managed by departments if and when necessary.

Bldg. HH – Week of July 14th for most employees. The TLO weeks will be managed by departments if and when necessary.

Bldg. LL/NN/SS/Tool Room – These buildings will have vacation shutdowns for the weeks of July 14 & 21. There were announced TLO shutdowns for these buildings for the weeks of September 29th, October 6th & November 17th & 24th.

Mapleton: A small percentage of departments were announced as vacation shutdowns for the week of July 7th. No announced TLO weeks.

Morton: No vacation shutdowns or TLO.

Tech Center: No vacation shutdown or TLO.

SPBU: No vacation shutdowns or TLO.

Mossville: No vacation shutdowns or TLO.

The Company could modify these dates and the number of people affected depending on the business climate.

Note: The Local 974 Union Hall will be open the entire month of July.

Right now, some of the Caterpillar Buildings in our local area are experiencing a downturn in business and the forecast that management has talked about in their meetings shows business will be flat through the end of the year. With this being noted, the company has put an emphasis on absenteeism. Members are being scrutinized for unapproved time off and subsequently being suspended and/or discharged.

So, the Membership needs to follow all of the procedures when taking time off that has not already been approved. ALWAYS call the Caterpillar Absence Line for every day you cannot make it to work. ALSO, contact your immediate supervisor. Keep track of all of these phone calls! If an illness or medical condition exists, get the proper information from a doctor ASAP to cover all of the days you were absent. If you cannot get in to see a doctor, go to a clinic or the emergency room to get the necessary information – very important. If your absence was due to other circumstances, obtain information to cover as an excuse (receipts).

In closing, I want to thank Rick DeGroot for his assistance in my transition to this office. We have known each other over the years and I respect his knowledge and his commitment to the Membership. Thanks Rick!

There is a message I want to state to all of the Membership, it is one word – *SOLIDARITY!* 

By attaining Solidarity within the Membership we can be better prepared in dealing with this Company on a daily basis. Solidarity will be a major tool for the upcoming negotiations.

Attend Union meetings, organize gatherings, communicate with your co-workers, all part of the Solidarity theme the Leadership needs from the Membership.

## **36<sup>TH</sup> CONSTITUTION** CONVENTION

There were 7 delegates elected to the Constitution Convention from our local. The delegates had several resolutions to consider from the membership

and International Executive Board. All of them were brought to the floor then every local had the opportunity to come forward and speak for or against. This is about the fairest and democratic process there is.

The one big piece of action that the delegates had was a lengthy debate on the half hour dues increase. I can tell you personally that there were a lot of good points brought forward to get to this decision. When you put all the facts on the table you get a real clear vision that if we want our brothers and sisters to get good wages & benefits, everything that each one of you deserves then we had to pass the dues increase, it was passed by a majority vote.

On the dues increase International will be sending out information around the first of August. It went from the basic 2 hours dues that was set at the Convention in 1967 to 2 ½ hours for the next four years, then it will have to be brought up at the next convention. There will be a vote to pass it again or to drop it back to the basic 2 hours. Remember if you don't work 40 hours in a month you do not owe dues for that month. This holds true if you are off on medical, workers compensation, etc.

When International President Dennis Williams gave his speech you clearly understand what our union is up against over the next four years. UAW will be negotiating contracts with General Motors, Ford, Chrysler, Navistar, John Deere, J.I. Case and Caterpillar.

President Williams made it clear that these companies are making billions of dollars. They're good about rewarding themselves but when it comes to rewarding the workers this is where they fall short!

"It's time to lift up people. It's time for each and every one of us to tell our corporations No More Concessions. We are tired of it. Enough is enough." I urge each of you to take the time and go online to uaw.org then click on newly elected President Williams's speech and hear it for yourself. If every brother and sister would take the time to hear it themselves then you will have a better understanding of what our International Union is up against.

On the local level since the election the Local President has taken the benefits office down to the Chairman Jim Arrowood and his assistant only three days a week, so make sure you call ahead for an appointment or you could be in for a very long wait.

Jim Arrowood, the Benefit Chairman and his assistant John Arnold have saved not only the local a lot of money over the years, but also the membership with the bills from everything from doctors, hospitals, medicine, ambulances etc. It's a great feeling to see the members walk out of the hall knowing that office just saved them sometimes thousands of dollars. Active members and retired still are getting their dues dollars' worth out of that office alone.

In my office the Local President is also cutting me down to a couple of days a week too. I was elected Financial Secretary Treasurer and always felt the best way to save this local money over the years is to be in the office getting our members the best deals with their dues dollars! Throughout the years I have diligently watched over the finances in keeping this local fiscally responsible. I oversee all expenses, order supplies, keep up with the maintenance. I also am responsible for monthly and yearly financial reports, LM2 reports to the Department of Labor, the 990 report to the Internal Revenue Service along with getting International copies too!

On to the shirt room it is also one of my responsibilities and I want to apologize for slacking in getting it restocked, but with my office I have to deal with what's on my desk and time related issues first. I will be working on getting it restocked.

I do want to thank the brothers and sisters for taking the extra effort to help get all the union shirts out to the shop. It shows our Union Solidarity!

## **INSURANCE & BENEFITS REPORT**

IIM ARROWOOD,

Chairman Insurance and Benefits

Since mid-June, the Insurance & Benefits Office has been staffed with one representative the majority of the time. President Smith has cancelled callouts I have submitted for help in handling your issues. I

reported at our Executive Board Meeting on June 9th that this office is impossible to run by myself. If you are experiencing delays, don't expect improvement until I can get some full-time help. When I began working in this office there were three representatives. When the Secretary Karol Lippert retired, we did not replace her. This was a decision that saved Local finances. When you elected me Chairman, the decision to run the office with 2 full-time reps is saving the Local even more. You deserve a fully staffed insurance and benefits office.

To help put this in perspective, just on the insurance side we have approximately 3600 active covered members. If all of them have spouses, add another 3600 covered lives. Many of them also have covered dependent children. Now consider the retiree group of covered lives. We have approximately 8000 retirees, many of them also have covered spouses, another 8000. The total members covered under various negotiated insurance plans now

becomes, give or take.... approximately 23,200. There is not enough room in our newsletter to cover all items in our insurance and benefit plan. Disability, life insurance, survival benefit eligibility, dental, vision and prescription. Now let's talk about the pension plans. Each retiree is covered under the specific group retirement plan in place at time of their retirement. We already did the math on the retiree population, approx.. 8000.

If you are a retiree, you paid dues your entire working life. Many of you also pay your voluntary dues. Active members also deserve full service from the Insurance & Benefits Office in a timely manner.

The Financial Secretary Treasurer's Office sits empty several days a week as well. Without John Shallenberger working every day in his office we will miss important opportunities to watch our finances and coordinate functions required by the Dept. of Labor.

Duties as important as ours requires a full-time, fully-staffed, Local Union.

You deserve better!



## **DENNIS WILLIAMS** IT'S OUR TIME TO GET IN THE FIGHT

Corporate America is failing in its responsibility to its workers and the nation and is failing at it, newly elected UAW President Dennis Williams told delegates in keynote address on the final day of the 36th UAW Constitutional Convention.

"Brothers & Sisters, companies around the globe are making billions and billions. Too many times they reward themselves and leave their employees too little to survive

on," Williams said.

"It's time to bridge the gap. It's time to lift up people. It's time for each and every one of us to tell our corporations: No more concessions," the UAW's President said. "We are tired of it. Enough's enough.

Our Congress also has a responsibility, to respond to the needs of the people, including passing a jobs bill, he told delegates.

At present, it is "handcuffed by extremists" who are preventing working people from getting ahead.

"We all want the same thing. We want to put America back to work. A 7percent employment (rate) is too high. We need bridges. We need schools. We need roads. We need a high-speed rail. It's time to bring America back to work!

"Here in the United States of America we have always had a strong economy when the middle class was growing, lifting people out of poverty," he said. "When Unions were thriving and people were making gains at the bargaining table, everybody did better. Everybody gains. They did better because people had disposable income. They could buy the car they built. They could buy a house. They could save for college and retirement.

"If people truly want their country back, it's time to stand up, take on the challenge, have a collective voice. America, rise up! Join a union! Get in the fight!

Unfortunately, many of our political leaders are too busy playing "the name game" instead of focusing on peoples' needs. Williams eschewed political labels, saying he's for a balanced budget, but not at the expense of hungry children, the poor or seniors on fixed incomes. He's for a strong defense, but not for leaders who would involve us in unnecessary conflicts. He hunts and owns guns, but believes reasonable rules should be in place.

"So there I am, I'm not a liberal. I'm not a conservative. I'm a trade unionist." Williams said to a standing ovation.

And as a trade unionist, he knows how critical it is to listen to the membership. It's one reason why PRO-Member was started. He related a story from early in his long career of union activism.

After winning a local election, a union brother gave him a book and asked him to read one sentence. So he did. It read: To be a great leader, you have to be an excellent listener."

It's a lesson that stuck with the former salvage welder at J.I.Case from his days at Local 806 all the way up to this week. He told delegates he intends to keep listening, even though sometimes what members have to say may be painful to hear.

"Brothers & Sisters, what our union is doing right now is we're listening," he said. "We want to rebuild this union in a way that gives pride to the UAW members and a sense of community."

He encouraged UAW activists to engage with members, and added we cannot be good stewards of the union if we cannot communicate and educate.

"If you can't talk to our members about what we are doing, perhaps we shouldn't be doing it." Williams said.

The new President took time to recognize former presidents of the union who persevered through their own difficult challenges. He thanked retiring leaders, including outgoing President Bob King, as well as his family, saying the union is grateful for his leadership and commitment to our movement.

"Your spirit, your dedication, your passion for the cause inspired all of us. Thank you so much," Williams said. "We all appreciate the solidarity you have built here at home as well as around the world. You opened new doors, forged new friendships and relationships with workers and unions around the globe.

"We know you will continue even though you have retired because really, that's who Bob is," Williams said.



"We know that we are up against an ideology in this country and 40 years of a right-wing-attack that has convinced people that somehow working hard should not necessarily mean that you have a decent life" said Henry, whose organization has been instrumental in recent rallies to organize low-wage fast-food workers and increase minimum wage to \$15.00 an hour. "Together we can turn that around because too many workers in this country are underpaid, Undervalued and underestimated.



## JERRY DIAS **UNIFOR**

Adult children are coming back home and it's a direct result of corporate greed, Unifor President Jerry Dias told delegates at the 36th UAW Constitutional Convention.

They live in a world that's turned upside down: They can't find jobs that support a decent standard of living and when they borrow tens of thousands of dollars to

upgrade their skills of education, they wind up underemployed and over their heads in debt.

"We told our young people, Go to school, get an education, get your college diploma, get your university education, upgrade your skills and your job will be waiting for you when you are finished," said Dias, who leads Canada's largest private-sector union, said. "They end up working part-time, precarious jobs because they've been betrayed."

But they are fighting back. Dias said Canadians are watching as fast-food and other low-wage workers take on greedy corporations whose executives are hauling in millions while paying substandard wages.

"Corporate greed has no conscience. Our members on your side of the border and our side of the border have been to hell and back," said the president of Unifor, which was formed last year when the Canadian Auto Workers merged with the Communication, Energy and Paperworkers Union. "You know why we formed Unifor in Canada? Because we're sick and tired of playing defense and is about time we all started to play offense!"

His union is doing just that. The straightforward former aerospace worker told delegates his union isn't afraid to use strikes or the threat of strikes to get members the wage increases they deserve or to save their plants. And Unifor stands ready to back our union in upcoming bargaining.

"Right now Unifor and the UAW need each other more than ever and I promise you this, and you take this as my solemn word: If you have a dispute in the United States because your members are fighting to improve their working conditions, there will be not one part from Canada that will come across the border that will weaken your bargaining position," he said to a standing ovation.

Dias said his union is watching the politics in the United States and had strong words for anti-worker conservatives in the United States such as South Carolina Gov. Nikki Haley, Wisconsin Gov. Scott Walker, Michigan Gov. Rick Snyder, U.S. Sen. Bob Corker and others who fight against a strong middle class.

"I listen to the foolishness of some of your politicians. I listen to Nikki Haley of South Carolina who says she doesn't want any employers to come to South Carolina if they have a relationship with the union movement she doesn't want them to 'taint the waters.' So I say to the Haleys, the Walkers, the Snyders and the Corkers of the world: You can kiss my union ass!"

## **BERTHOLD HUBER** INDUSTRIAL UNION PRESIDENT

Speaker from German Works Council speaks on VW vote in Tennessee

In his more than 25 years in working with employers and employees to organize and create works councils, he has never seen such anti-union activity as he witnessed in Chattanooga, TN.





## The Editor's Desk By Rick Corbin

By now most have seen the news that GM is recalling more vehicles for repairs not related to the ignition switch controversy. This time the Corp. is being proactive and recalling vehicles at their initiative, not because of some crisis. This is the way we would expect them to behave. Maybe this is a lesson learned.

I also included a note of some recalls from Honda Corp. just so you know GM isn't the only one with a supplier problem.

#### **OFFICIAL**

Honda Fit, Vezel Hybrids recalled in Japan; US vehicles not affected:

Honda has announced a good-size recall of two popular Japanese-market hybrids; the Fit Hybrid and the Vezel Hybrid are both headed back into the garage. The problem this time around lies in the software program that controls the 7-speed dual clutch transmission (DCT) that could "cause a delay in the ability to begin driving or the inability to move at all." In total, 81,353 units are affected (70,929 Fit Hybrids and 10,424 Vezel Hybrids) and all were made in Japan between July 2013 and February 2014. There were two previous recalls for the new Fit Hybrid's DCT, and you can find the details of them below.

Jessica Fini, assistant manager of PR for Honda North America, told AutoblogGreen that this recall will not have any impact on US Honda vehicles. For one thing, the US Fit has a continuously variable transmission (CVT) instead of a DCT, so the upcoming launch of the new Fit here (the US doesn't get the Fit Hybrid) will not be delayed. Honda's upcoming small SUV in the US (based on the Vezel, but will arrive with a different name) isn't going to launch here until the end of the year, so there is time to fix any problems before launch. She also said that the Acura RLX, despite being a DCT, does not use the same transmission as the Fit Hybrid does, since the Fit transmission is specific to the one-motor hybrid system and the RLX uses three electric motors.

## MAPLEVILLE REPORT - PAUL JACKSON, CHAIRMAN

#### **HELL FREEZES OVER!**

When I last left the Foundry in 2000, after my 2nd tour, the chances of me returning was the same as the band, The Eagles, getting back together for a reunion tour, as stated by Don Henley, "WHEN HELL FREEZES OVER".

Well, May 27, 2014 marked the 20 year anniversary of that tour and June 16, 2014 I started my 3rd tour of the Mapleton Foundry.

I'm easily recognizable by the day glow yellow vest that is designed to protect you from all harm. During my introductory tour, it was evident by the fact a young man was adding alloy to the smelting pot; he instantly turned into a human sparkler, yet walked away unharmed, by the 3000 degree iron.

#### **MAPLEVILLE**

Last tour was in the basement 90 feet below the area I was servicing. This tour, I am assigned to the area referred to by many as Mapleville. It is comprised of Mossville machinists, machines dotted with new state of the art machining centers. Main product is head and liners, some blocks are machined in the debarking area, but that area was there prior to Mapleville area. It is where most of the Mossville folks, including yours truly will end their careers. At last estimate there was north of 200 people that could retire tomorrow at Mapleton, most located in Mapleville.

### IT PASSED

Last month at the UAW Constitutional Convention, elected delegates from our Local and Locals all across the U.S. and Canada passed the first dues increase in 47 years. Was it the right thing to do, YES. Was it horrible timing, absolutely. Also, we had our triennial elections and we heard the Membership loud and clear. If the dues increase passes, we expect all reps from the top down to be fiscally responsible. Local 974 President was way out ahead of that, like he is most things, prior to the election. Because of the way the grievance procedure was reformatted and strengthened, the Hall had to invest money to level the bargaining field with the company. Over the past 3 years since we settled the contract, we spent that money well. I can tell you from over 30 years of grievance handling that our new system is second to none. We finished the reorganization just prior to the election, so we knew that after the election, we had, in order to better serve the membership, reorganize the Local. We needed to stop running the Hall like we did when we had 10,000 members. The reorganization that is in progress will make us not only strong financially but will prepare us for the next set of negotiations. Most Locals our size do not have full-time officers, with the exception of the office of President, who generally serves as chief bargainer also. The demographic of our Local make that unfeasible. President Smith represents all the units in bargaining, but each one has their own bargaining chairman, therefore with 3,800 active Caterpillar employees our bargaining chairman must be full time. With 85% of our membership being post 2005, fortunately the Local does not have to spend money on pension issues, like we did in the past and since we bargained dues checkoff in the last contract. Our full-time secretaries keep the dues office running with little or no management. This also saves the Local money. So overall we are in good shape, but the Membership has put the Local and International on notice, take better care of our dues. We are listening and tightening our belts. 2017 will be here sooner than you think.

#### **BUY UNION - BUY AMERICAN**

Easier said than done, I know. We need to try. I read an article recently about the effects of buying American. If everyone in America would buy just 1% more American made products it would create 250,000 jobs a year. Sometimes you have to look and look twice. Some products like light bulbs, clothing and tools have an American option and we just have to make the effort. Steel toe work shoes for example – at Mapleton Cat pays \$120, but carries 1 or 2 styles. Holmes Shoes in Peoria has a whole wall of American-made work boots. I asked for a discount, they gave me 15% off and then I applied my Cat allowance and got a superior Carolina work boot for a few dollars more than the cheaper low quality China brand. I do most of my shopping at Kroger -- there again, hometown, Union labor and Kroger brand is lower cost and actually preferred by my family to the brand name. Heartland vision, Union, and always with my union discount is cheaper in a lot of cases than I can buy online. Just one purchase a week can make a huge difference. Imagine if you will a pond, you pick up a small, what seems to be an insignificant pebble, and when you drop it in the water it makes a small circle in the water's surface, but watch closer and see the ripple effect that one small pebble makes, the subsequent circles seem to go on forever. The rest of the year try the 1% theory and make some big ripples.
