
Doug Stephens recently shared an article written by the Illinois Trial Lawyers Association with me that was published in the Chicago Sun-Times on February 6, 2018 and I would like to share some of the highlights of that article with our membership.

Illinois lawmakers rewrote the Workman's Compensation Statute in 2011 to cut costs to businesses and insurance companies at their urging. These changes negatively impacted our membership by taking away long standing rights. The understanding was that the insurance companies would pass on the savings to Illinois businesses, but the insurance companies have refused to pass these savings on to the businesses.

Total benefits paid to medical providers and compensation paid to injured workers dropped 19.3% between 2011 and 2015 in Illinois. The insurance companies experienced a profit of nearly a half a billion dollars in 2015, so the 2011 workers compensation rewrite has worked in cutting costs. If there are any further revisions, they should focus on the unjust premiums that the insurance companies are charging the businesses in Illinois.

We will have a new member orientation at the hall on April 23rd with meetings at 8:00 a.m., 1:00 p.m. and 4:15 p.m. all supplemental members or members who have been converted in the last 3 years are eligible to attend. We are pleased to have Brad Schwanda from the International come down to run the meetings.

INSURANCE & BENEFITS REPORT

JOHN ARNOLD ————

Well, it's been a long winter and I don't know about you but I'm ready for spring to start. We are now a few months into the year and hopefully everybody's issues with the premiums have been taken care of. In September/October of 2017 I had Physician's Mutual come in and hold seminars for the retirees that were considering the management plan that Caterpillar was offering so they could better understand the options they had in front of them. Those seminars were such a big success that we will be having more of them this year.

Starting April 24th, and every 4th Tuesday of each month going forward, we will be having a seminar at 10 a.m. and 4 p.m. for all active members and their spouses. These seminars are for members that are looking to retire in the near future and want a better understanding of how the insurance is going to work for them and their dependent(s) once they reach the age of 65. As of the writing of this article I still have not heard if Caterpillar will be offering this management plan again to any past retirees. But, if you are a retiree that retired January 10, 2005 thru March 1, 2017 you are more than welcome to come listen and possibly understand the management plan. BUT TO MAKE IT VERY CLEAR, THE MANAGEMENT PLAN MAY NOT BE OFFERED AGAIN TO THOSE THAT RETIRED BETWEEN JANUARY 10, 2005 AND MARCH 1, 2017.

During last year's enrollment process in trying to decide if someone should go with the management plan or not, there was a question as to whether you would be able to transfer back into your 2017 plan if you went into the management plan. We now have the answer to that question and it is No. If you decided to go into the management plan and thought you'd give it a year and come back to the old plan that is NOT an option for you. Once you leave the plan you cannot come back if you retired on or after January 10, 2005.

ATTENTION: Employees that are eligible to retire under this contract need to read this. If you have a monthly pension coming to you and you meet the requirements for said pension and you want the \$10,000 bonus you **MUST** fill out the "Application for Retirement Bonus Payment" to qualify for that \$10,000. You must contact the Facility LR Manager to get this form and you must have it turned in by August 31, 2018. Any application turned in after that date will not be accepted.

Also, if you don't retire by January 1, 2019 you run the risk of having your HRA payment be lower than what it is now. For an example if you are 63 years old now and retire by January 1, 2019 when you turn 65 years old you will get the full \$3,000 HRA payment for you and your spouse. However, if you are 63 and you wait until say June 1, 2019 and you retire with 30 plus years, you will only get \$2,760 for your HRA payment for you and your spouse once you turn 65 years old.

If you are thinking about retiring and you want to know how the insurance is going to affect you depending on when you retire, please call me so I can answer those questions. January 1, 2019 is a critical date for a lot of our members that I don't think has been stressed enough.

As always please call me if you have any questions about your insurance. I will do my best to get you the answers you seek.

RETIREES - Medicare Reimbursement

From time to time, I remind our retirees about the Medicare Part B reimbursement portion of our plan. If you or your spouse are Medicare age, 65, and enrolled in Medicare Part A & B, you are eligible for reimbursement of the Part B Premium. The Plan will reimburse your Medicare premium up to \$99.50 per month every January and July. This only pertains to members and spouses that opted out of the management/executive plan and retired prior to March 26, 2017. You must contact Alight Solutions (Hewitt) at 1-877-228-4010 to enroll for the reimbursement. Once you're signed up, you won't have to sign-up again.



BARGAINING CHAIRMAN'S REPORT

Greetings Brother and Sisters,

Here we are already in March of 2018. On February 12th thru 14th, Randy Diehl and I were invited to Detroit for a Meet and Greet with the new Vice-President of the International Terry Dittes. It was a very informal meeting that lasted about 50 minutes with a question and answer session afterwards.

On February 9th we held our final rounds of new stewards training we had 52 called out with 31 attending.

Just to let the members know if you are on callout from the hall the union pays your insurance for the time you are called out, plus your wages. So if you are sick or have something that is going on to interfere with your callout, you need to inform the hall in advance. When you don't show up your callout is cancelled, and may cause some attendance issues depending where you are at in the P.A. chain.

On April 23rd we will be having a New Member Orientation which has not been done for a while. Randy invited Brad Schwanda from the International to come down to the hall and give the presentation.

We currently have 24 grievances on our docket, 11 issue grievances and 12 just cause grievances.

The International is in the process of scheduling docket meetings with the company to discuss Morton facilities grievances. All of grievances are just cause grievances.

The company fired Michael T. Latino which heard the issue grievances. He has yet to be replaced.
