RETIREES - Medicare Reimbursement

From time to time, I remind our retirees about the Medicare Part B reimbursement portion of our plan. If you or your spouse are Medicare age, 65, and enrolled in Medicare Part A & B, you are eligible for reimbursement of the Part B Premium.

The Plan will reimburse your Medicare premium up to \$99.50 per month every January and July. This only pertains to members and spouses that opted out of the management/executive plan and retired prior to March 26, 2017. **You must contact Alight Solutions (Hewitt) at 1-877-228-4010 to enroll for the reimbursement. Once you're signed up, you won't have to sign-up again.**

ARTICLE 12 SALARIES AND HOURS OF EXECUTIVE BOARD MEMBERS

Section 1.

- (E) Anyone that is participating in the TDRP at Caterpillar, is called out and in the 403B program at the Union Hall, shall have their contributions to the 403B matched at \$.50 for every \$1 they put in up to 6% of their weekly wages. That matching contribution will show as a 'bonus' on their checks each pay period. Those monies would then be deducted and forwarded directly to the 403B. That matching contribution is subject to FICA taxes. Plus, they will receive the annual 3% contribution by the Union Hall at the end of the year on their yearly wages.

CHANGE TO READS AS:

ARTICLE 12 SALARIES AND HOURS OF EXECUTIVE BOARD MEMBERS

Section 1.

- (E) Anyone that is participating in the TDRP at Caterpillar, is called out and in the 403B program at the Union Hall, shall have their contributions to the 403B matched at the same rate as per the contract language for their weekly wages. BARGAINING CHAIRMAN'S REPORT – AUGUST 2023

Greetings Brother and Sisters,

I hope everyone is doing well and enjoying the summer.

Steward Triennial Elections have wrapped up for this term and we sent 32 union stewards to Ottawa for Steward training. This training is the best money spent to arm our front-line stewards with the knowledge of the grievance procedure. It's always exciting to hear from the ones attending upon their return, of their experience.

For those who didn't attend the Ottawa training and have had no training at the hall, I will begin steward training at the union hall in the month of August.

As I write this article the docket agenda is at 5 issue and 8 just cause. I currently have 5 grievances I'm working on and reports of more coming. Reports from the grievance committees is that they see a trend of the company being firmer on discipline as of lately. It is my belief that we have newer labor representatives currently that are not working with our committees to resolve the less serious infractions our members may be facing, or making more out of the infraction than needs to be. It also appears that the newer labor representatives are not fully investigating situations before dishing out discipline.

For those being put on attendance verification, as some may know, it is a vicious circle. Please use the new contract language of Y-time (unforeseen circumstances – call in at least 30 minutes prior to your shift) to help remove the attendance verification. This was very difficult to do prior to the Y-time language added to this contract. When placed on attendance verification you are required to go 12 months with no unexcused absences. This is very difficult to achieve for anyone, but with the new Y-time language it can be done now.

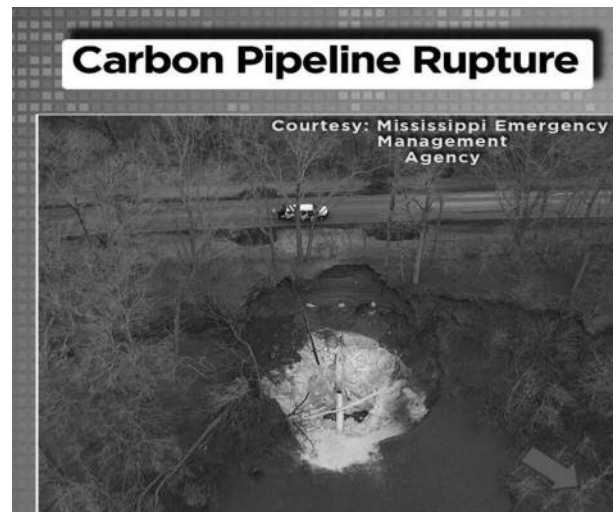

Carbon Dioxide Pipeline Risks to Peoria County Residents

Look at this:

- A CO2 pipeline ruptured a mile from rural Satartia, Mississippi, and the gas traveled.
- 200 people were evacuated, 45 sent to hospital including first responders.
- The rupture created a 40 ft. deep crater in the ground, spreading dry ice.
- A CO2 pipeline rupture can have a cloud of carbon dioxide, which displaces oxygen.
- CO2 does not have enough oxygen to breathe.
- High levels can result in convulsions or death within minutes of lasting health issues.
- Gas and diesel vehicles will not run if there is not enough oxygen.
- U.S. CO2 pipeline regulations are being reviewed since the Satartia incident.
- Updates to regulations are not expected until late in 2024.

To all Peoria County Veterans if you need assistance please call (309) 681-2554 that is the number of the Peoria County Veterans Assistance Commission.

Veterans Affairs Secretary Denis McDonough recently said veterans' mistrust or misunderstanding of Federal Assistance programs, may be stopping them from getting millions of dollars in benefits. He also said that he and other top Veterans Affairs officials are advocating for veterans to screen for toxic exposure injuries. These financial benefits are available under the PACT Act which was passed last summer. For those who are Vietnam Veterans there are benefits for those who suffer from hypertension and monoclonal gammopathy. So far only 10% of veterans are potentially eligible for benefits under the new toxic exposure legislation which was also approved last year. Only a few veterans have filed claims.

On September 15, 2023, we will be hosting the POW/MIA Day Dinner at UAW Local 974 for veterans and their families. We will have speakers from the Veterans Assistance Commission and Honor Flight.
